JULY -2018, TUITION FEES COLLECTION MODALITIES

1. Fees shall be accepted by DJMIT A/C section by Cheque or Draft only as per the schedule displayed on the DJMIT Notice Board.
2. Cheque or Draft Should be in favor of "**Dr. Jivraj Mehta Institute Of Technology**"
3. Cheque or draft should be payable at par. It should be CTS cheque. **Cheque of Co-operative bank or local gramin bank will not be accepted.**
4. Bouncing of Cheque is a serious offense punishable under IPC. Management will take action accordingly in case of bounce of cheque.
5. **Late payment of fees:** Payment of fees after stipulated dates i.e. after **15/07/2018**, for all semester shall be considered as late payment and shall be

liable for penalty of **Rs.50 per day**. Payment of fees with late fees shall be collected **only by DJMIT account office**.

6. The grace period for late payment of fees with penalty shall be **10 (Ten) days (from 15/07/2018 to 25/07/2018)**. No fees shall be accepted after grace period & such students shall be dealt with penal action including keeping the admission of such student in abeyance or termination or suspension of admission in accordance with provisions of GTU/ACPC/DTE Govt. of Gujarat as may be applicable from time to time in such cases. However it will be at the discretion of the management to decide such issues on individual basis regarding acceptance or rejection of fees. The decision of management shall be final.
7. Students shall require to produce the fee receipt in original whenever asked by the Admin, therefore, fee receipt should be kept carefully.
8. All detained students who had paid tuition fee previously have to show their original Fee receipt, for verification, to Account section during office hours
9. This notice is served on all college notice boards and penalty for non payment of tuition fees shall be done on the basis of this notice and hence all concerned students shall take suitable note of this important notice.
